DCHC MPO PRIVACY POLICY**

This Privacy Policy will apply to the website that you are visiting, dchcmo.org (the “Website”), which is owned by DCHC MPO (the “Organization”) Organization and its subsidiary organizations respect the privacy rights of our online visitors and recognize the importance of protecting the information collected from you. We have adopted an organization wide Privacy Policy that guides how we collect, store and use the information you provide online. Please note that this policy applies only to sites maintained by DCHC MPO and its subsidiaries, and not to websites maintained by other organizations or agencies to which we link.

Information Collection and Use

Our primary goal in collecting personally identifiable information is to provide you with the products and services made available through the Website, including but not limited to our services, to communicate with you, and to manage your registered user account, if you have one.

Information Collected Upon Registration If you desire to have access to certain restricted sections of the Website, you will be required to become a registered user, and to submit certain personally identifiable information to DCHC MPO. This happens in a number of instances, such as when you sign up for services, or if you desire to have access to the partner portal. Personally identifiable information that we may collect in such instances may include your full name, username and password, email address, time zone and other information that you decide to provide us with or that you decide to include your public profile.

Use of Contact Information We will NOT use your personal information to provide marketing tools to you. We respect your privacy and will not use your information or provide it to any third party for any purpose.

Log Data We will not collect and save Log Data from users. Lot Data includes information such as user’s domain, browser and IP address. We respect the privacy of users and will not collect this information.

Your Account If you use this site, you are responsible for maintaining the confidentiality of your account and password and for restricting access to your computer, and you agree to accept responsibility for all activities that occur under your account or password. DCHC MPO reserves the right to refuse service, terminate accounts, remove or edit content in their sole discretion.

Cookies We use cookies and other technologies to passively collect demographic information, personalize your experience on our website and monitor other activities. Cookies are small files downloaded to your computer to track movements within a website. We may link cookie information to personal information. Cookies link to information regarding what pages you have viewed. This information is used to keep track of your navigation of pages on the website. You can disable cookies or set your browser to alert you when cookies are being sent. However some areas of our sites will not function properly if you do so. Please note that this privacy policy covers the use of cookies by DCHC MPO only and does not cover the use of cookies by an advertiser.

Third Party Services Users may register for other services found on our Website. Certain services or products may be available on our Website provided in partnership with third parties’ and may require you to disclose personally identifiable information in order to register for and access such products and / or services. Such products and/or services shall identify the third party partners at the point of registration. If you elect to register for such products and / or services, your personally identifiable information will be transferred to such third parties’ and will be subject to the privacy policy and practices of such third parties’. We are not responsible for the privacy practices and policies of such third parties’ and therefore you should review the privacy practices and policies of such third parties’ prior to providing your personally identifiable information in connection with such products and /or services.

Service Providers We engage certain trusted third parties to perform functions and provide services to us, including, without limitation, hosting and maintenance, relationship management, database storage and management and email campaigns. We will share your personally identifiable information with these third parties, but only to the extent necessary to perform these functions and provide such services, and only pursuant to binding contractual obligations requiring such third parties to maintain privacy and security to your data.

Law Enforcement We cooperate with government and law enforcement officials or private parties to enforce and comply with the law. We may disclose any information about you to government or law enforcement officials or private parties as we, in our sole discretion, believe is necessary or appropriate to respond to claims, legal process (including subpoenas), to protect the property and rights of DCHC MPO or a third party, the safety of the public or any person, to prevent or stop any illegal, unethical or legally actionable activity, or to comply with the law.
