SUBJECT: Budget allocation to meet needs of Transit Partners - Orange

Strategic Objective or Initiative Supported

This item supports initiative 1.2, "Pursue service improvements and expansion opportunities"

Action Requested

The Operations and Finance Committee is requested to recommend approval of the FY18 budget amendments to the GoTriangle Board of Trustees at the February 28, 2018 meeting. The above actions were recommended for approval by the Orange County Staff Working Group.

Background and Purpose

In May 2017, the Town of Chapel Hill requested that services previously implemented with Transit Tax revenues be continued through FY18 and an additional 2,500 hours of revenue service be initiated. GoTriangle budgeted \$1,512,362 for these purposes. Subsequently, Chapel Hill Transit staff noticed that GoTriangle had inadvertently left off the HS route operations which was included in the previous years. The revised estimated cost of all services with the HS route is \$1,565,500.

Financial Impact

The proposed Budget Ordinance Amendment provides additional funds needed for transit operations

• Chapel Hill Transit – Budget increase of \$53,138, which is within Chapel Hill Transit Plan FY18 total available operating budget of \$2,019,000.
