

**RESOLUTION TO MODIFY THE 2024-2033 TRANSPORTATION  
IMPROVEMENT PROGRAM FOR THE DURHAM-CHAPEL HILL-CARRBORO  
METROPOLITAN PLANNING AREA**

**AMENDMENT #1**

**January 23, 2024**

A motion was made by MPO Board Member *Jamzetta Beckford* and seconded by MPO Board Member *Jamela Caldwell* for the adoption of the following resolution, and upon being put to a vote, was duly adopted.

**WHEREAS**, the Transportation Improvement Program (TIP) is a staged multiple year listing of all federally funded transportation projects scheduled for implementation within the Durham-Chapel Hill-Carrboro Metropolitan Planning Area which have been selected from a priority list of projects; and

**WHEREAS**, the document provides the mechanism for official endorsement of the program of projects by the MPO Board; and

**WHEREAS**, the inclusion of the TIP in the transportation planning process was first mandated by regulations issued jointly by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) and no project within the planning area will be approved for funding by these federal agencies unless it appears in the officially adopted TIP; and

**WHEREAS**, the procedures for developing the TIP have been modified in accordance with certain provisions of the MAP-21 Federal Transportation Act, the Infrastructure Investments and Jobs Act (IIJA), and guidance provided by the State; and

**WHEREAS**, projects listed in the TIP are also included in the State TIP (STIP) and balanced against anticipated revenues as identified in both the TIP and the STIP; and


**WHEREAS**, the North Carolina Department of Transportation and the MPO Board have determined it to be in the best interest of the Urban Area to amend the FY 2024-2033 Transportation Improvement Program as described in the attached sheets; and

**WHEREAS**, the United States Environmental Protection Agency Designated the DCHC MPO from nonattainment to attainment under the prior 1997 Ozone Standard on December 26, 2007; and

**WHEREAS**, the DCHC MPO certifies that this TIP amendment is consistent with the intent of the DCHC MPO 2050 Metropolitan Transportation Plan (MTP); and

**WHEREAS**, in accordance with 23 CFR 450.326 (d), the TIP shall include, to the maximum extent practicable, a description of the anticipated effect of the TIP toward achieving the performance targets identified in the metropolitan transportation plan, linking investment priorities to those performance targets; and



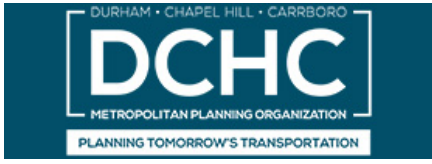
The Town of Chapel Hill contracted with TranSystems (formerly known as SEPI Engineering) for Construction, Engineering, and Inspection (CEI) services for the C-5179 Estes Drive Bicycle and Pedestrian Improvement project in August 2021. The original contract and cost estimate was based on a 15-month construction and closeout period. While there have been periods of little to no work on the project, the contract with TranSystems is almost expended and the project is still underway.

TranSystems submitted a request for an additional 9 months of funding to continue CEI services for the duration of the project - **\$204,964.63**. The Town and the North Carolina Department of Transportation (NCDOT) have approved the request and the Town seeks additional **\$163,971** in DA funds from the Durham-Chapel Hill-Carrboro Metropolitan Planning Organization (DCHC MPO) to cover the cost.

The Town of Chapel Hill allocated \$300,000 of local funds to the project in 2022 to cover construction supplemental agreements and eventual contractor claims. **\$40,993** of this local funding will cover the required 20% local match for the CEI funding.

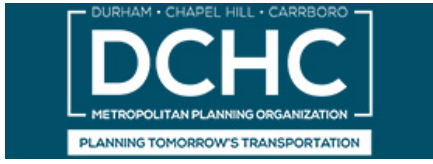

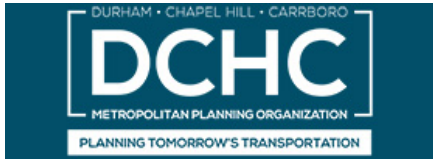

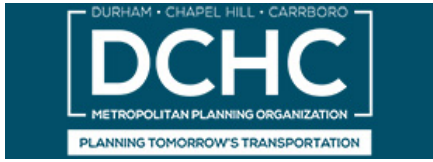
